Town of Perry Minutes of Town Board Meeting Tuesday, December 10, 2024 Perry Town Hall

 Call to order. Chairman Roger Kittleson called the meeting to order at 7:00 PM. Supervisors Ken Hefty and Mick Klein Kennedy, Treasurer - Deputy Clerk Stephanie Zwettler and Clerk Mary Price were present. Also in attendance: Mark Eastman, James Gibson, Sue Medaris, Atty. Mark Rooney and Doug King via teleconference.

Pledge of Allegiance. Chairman Kittleson led the Pledge of Allegiance.

Moment of Silence – Chairman Roger Kittleson requested a moment of silence in remembrance of Georgia Post, Virginia Friske and Mark Koeppl.

- Convene Closed Session, WI § 19.85(1)(b) and (c) Employee compensation, commission and committee reviews. Roger Kittleson moved and Mick Klein Kennedy seconded a motion to convene a closed session to discuss employee compensation, commission and committee reviews. per WI § 19.85(1)(b) and (c). Roll call vote: Ken Hefty Yes; Mick Klein Kennedy Yes; Roger Kittleson Yes. Motion carried.
- 3. Reconvene Open Session. Set employee 2025 compensation. Roger Kittleson moved and Mick Klein Kennedy seconded a motion to reconvene the open session. Roll call vote: Ken Hefty Yes; Mick Klein Kennedy Yes; Roger Kittleson Yes. Motion carried. The open session reconvened at 7:28PM.

Set employee 2025 compensation. Roger Kittleson moved and Mick Klein Kennedy seconded a motion to change the compensation effective January 1, 2025 for Patrolman Mark Eastman to \$38.00 per hour; match the Patrolman's 3% contribution to the Town's Simple IRA; \$4.75 per hour contribution to Health Reimbursement Savings Account; nine (9) sick days per year with 50% vested to be reimbursed at the end of employment; twelve (14) vacation days per year; seven (7) holidays per year – New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Friday following Thanksgiving Day, and Christmas Day; up to \$175.00 clothing allowance per year; and to allow up to 240 hours of compensatory time per year – up to 100 hours can be carried to next year and remaining compensatory time to be paid by year end; to confirm per diem rate at \$40.00 for Town Board meetings and Mt. Horeb Fire Department meetings. Motion carried.

Mick Klein Kennedy moved and Roger Kittleson seconded a motion to change the compensation for 1st Assistant Patrolman to \$35.00 per hour and the 2nd Assistant Patrolman to \$32.00 per hour effective January 1, 2025. Motion carried. Ken Hefty – abstain. Motion carried.

Roger Kittleson moved and Mick Klein Kennedy seconded a motion to authorize the compensation for the Recycling Center Attendants at \$26.00 per hour effective January 1, 2025. Motion carried.

Ken Hefty moved and Mick Klein Kennedy seconded a motion to increase per diem rate for Land Use Committee members to \$45.00 effective January 1, 2025. Motion carried.

- Announcements. Clerk Mary Price distributed the Town's 2025 meeting calendar; presented the Town's WI DOR Allowable Debt calculation -\$6,405,085 and current debt - \$585,737.00
- 5. Roads, Equipment, Facilities
 - a. Truck & Snowplow delivery and financing update. Road Patrolman Mark Eastman reported the new truck will be delivered in mid-January. Ken Hefty moved and Mick Klein Kennedy seconded a motion to extend the new truck short-term financing three months. Motion carried.
 - b. Process and requirements to discontinue a Town road WI §66.1003, etc. James Gibson and Sue Medaris clarified the road length to be and their reasons to request that the Town discontinue a portion of Moen Road. A Petition for Discontinuance of Part of a Public Way prepared by and submitted by Atty. Joshua Weishaar will be considered at the next Town Board meeting.
 - c. Clerk Mary Price presented updated WI DOT information from Town of Blue Mounds Chairman Dennis Jelle and an additional community meeting might be scheduled to discuss reengineering Hwy. 78.
 - d. Mark Eastman, Road Patrolman, reported the WI DOT culvert inventory was submitted before the deadline.
- 6. Recycling Center. Replace shed. Mark Eastman reported the new shed is scheduled to be delivered to the Recycling Center on Dec. 17. Styrofoam insulation will be installed by the Town.
